This memorandum is being issued to notify you that the Office of the Public Auditor is required by law to provide notice to all directors of their responsibilities pursuant to Public Law (P.L.) 29-113, the *FY 2009 Budget Act*, passed in September 2008.

Please submit a "nil" report if you believe one or more of the reporting requirements are not applicable to your entity.

We also recommend the posting of the transmittal letter(s) with the receipt acknowledgement from the Speaker's office, as well as a copy of the electronic submission, on your website.

For your convenience, we have enclosed your department/agency's reporting requirements. Please review these as well as the *FY 2009 Budget Act* to ensure that you are aware of all your requirements. Failure to comply with any of the reporting requirements will result in a 20% salary reduction for you, your deputy and your Chief Financial Officer. You may also view the reporting requirements at our website, [www.guamopa.org](http://www.guamopa.org). These were also sent via email. If you did not receive it, please contact our office so that we may update our database.

To comply, each entity must (1) provide an electronic format of the report to all Senators (CD, diskette, and/or e-mail); (2) post the report on the website; and (3) submit one hard copy of said report to the Speaker of I Liheslaturan Guahan.
